- ✓ Publications on social networks and dissemination of the project

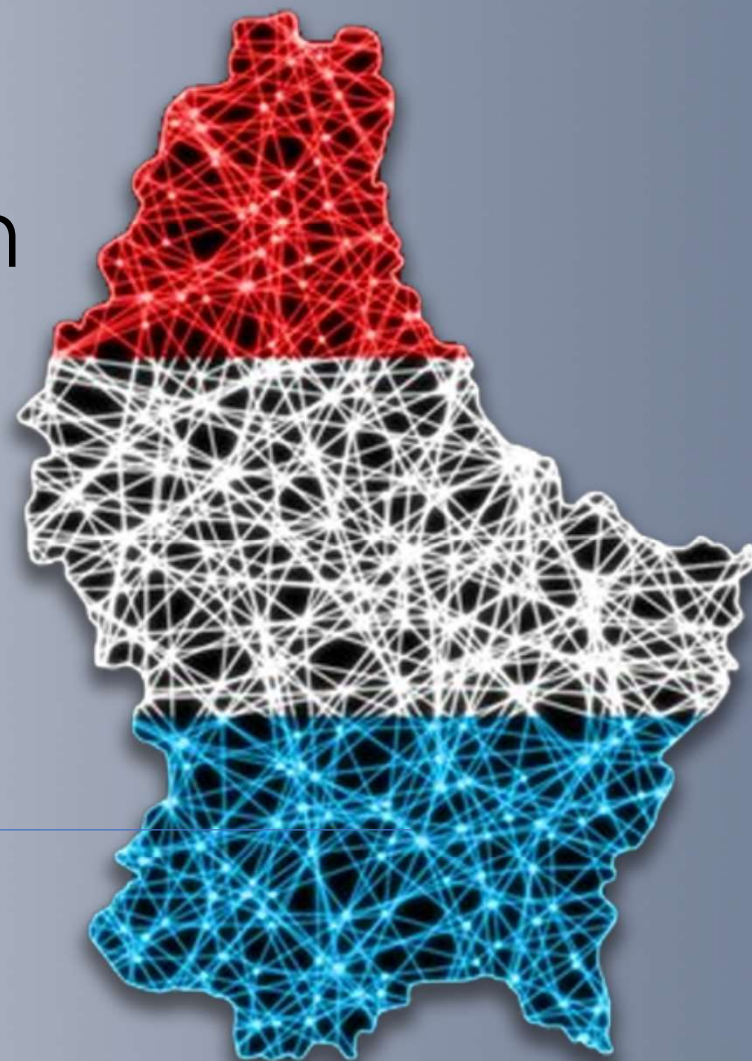
